Note: In November 2020, the Department of Finance implemented Phase One of the new Integrated Revenue Administration System for personal income tax withholding, realty transfer tax, gross receipts tax, and all other license taxes. During the implementation, the processing of returns and payments was temporarily paused to allow for entry into the new system in early December. As a result, the State's accounting system does not reflect all revenues that would have traditionally been recorded in November. For DEFAC purposes, year-to-date revenues have been adjusted to account for this change.
